

Terms and Conditions — Start Now, Pay Half Offer (CCS Bridge)

1. The Promoter

This offer is run by **Amara Early Learning Centre** ("Amara", "we", "us", or "our").

By enrolling with Amara under this offer, you agree to these Terms and Conditions in addition to Amara's standard enrolment terms.

2. Offer Summary

Amara will apply a **50% discount to its standard daily gross rate** for eligible new enrolments for a period of **six (6) weeks from the child's first day of attendance**. The discount applies as a flat 6-week period regardless of when (or whether) the family's Child Care Subsidy (CCS) becomes active.

3. Offer Period

- **Start date:** 5 May 2026
- **End date:** 30 June 2026, OR when CCS Pending spaces are filled (at Amara's discretion) — whichever occurs first
- Amara reserves the right to extend, shorten, or withdraw the offer at any time at its sole discretion, subject to applicable law.

4. Eligibility — Who Can Participate

To qualify for this offer, you must:

- Be a new family to Amara — not a currently enrolled family, and not a family who has previously withdrawn and is re-enrolling
- Be enrolling a child aged 0 to 5 years
- Enrol for a minimum of **two (2) days per week**

- Provide, at the time of enrolment, documented proof that a Child Care Subsidy (CCS) application has been submitted to Services Australia on behalf of the enrolling child. Acceptable proof includes:
 - A screenshot of the myGov / Services Australia CCS application confirmation page, showing your name, the date the application was submitted, and a status such as "Submitted" or "Being processed"
 - A PDF of the same
 - Sign Amara's standard enrolment agreement
 - Not be an employee, director, or immediate family member of a staff member or owner of Amara Early Learning Centre or Living Online Pty Ltd
- Only one application of this offer is permitted per family per child.

5. The Discount

- **Discount amount:** 50% off Amara's daily gross rate ("Daily Rate")
- **Daily Rate as at launch date:** **\$160** per day. If Amara's Daily Rate changes during the offer period, the 50% discount applies to the Daily Rate in effect at that time.
- **Discount applied to:** Standard childcare fees only. Non-standard charges (e.g. late pick-up fees, excursion fees outside the standard fee structure, replacement items) are charged in full.
- **Payment timing:** Discount is applied at the time of invoicing. Families are invoiced at the 50% rate (**\$80** per day at the launch Daily Rate) for all booked days during the 6-week discount period.
- **CCS reporting:** During the discount period, the session fee reported by Amara to Services Australia under the Family Assistance Law is the discounted Daily Rate actually charged to the family (**\$80** per day at the launch Daily Rate). Where CCS is active during the discount period, the CCS subsidy is calculated against this discounted session fee and reduces the family's out-of-pocket cost in the usual way.

6. Discount Duration — Cessation Triggers

The discount ends automatically on whichever of the following events occurs first:

(A) SIX WEEKS OF ATTENDANCE

The discount ends at the conclusion of the sixth (6th) week from the child's first day of attendance. Attendance for this purpose means any week in which the child is booked to attend, regardless of whether the child was actually present on all booked days (absences do not extend the 6-week window).

(B) ENROLMENT ENDS OR IS SUSPENDED

If the enrolment is terminated or suspended during the 6-week window, the discount ends from the date of termination or suspension.

(C) OFFER PERIOD CLOSES

If the broader offer period (30 June 2026) closes, existing enrolments already enjoying the discount will continue to receive it until one of the above triggers (a)–(b) occurs. New enrolments will not be eligible after the offer period closes.

7. What Happens After the Discount Period

- From week 7 onwards, the enrolment continues under Amara's standard terms and full Daily Rate (**\$160** per day at the launch Daily Rate)
- From week 7 onwards, the session fee reported by Amara to Services Australia is the full Daily Rate, and any active CCS subsidy is calculated against the full Daily Rate
- If CCS has not yet been approved at the end of the 6-week discount window, the family pays the full Daily Rate from week 7 until CCS is activated. Back-payment may be available via Services Australia, subject to their policies.
- **Backdated CCS approvals:** Where Services Australia backdates a CCS approval to cover days within the 6-week discount period, any CCS amount payable for those days will be calculated against the **\$80** discounted session fee. Services Australia will either remit that amount to Amara as a credit to the family's account (which will be applied against the family's next invoice before any funds are debited from the family's nominated account), or pay it directly to the family. Amara will not retroactively re-bill the family for the difference between the discounted rate and the full Daily Rate.
- Amara's 3 Days CCS Guarantee and any other standard Amara programs apply per their usual terms

8. What Happens If CCS Is Denied

- If the family's CCS application is denied by Services Australia, the discount provided up to that point stands — Amara will not seek to recover it
- From the date of the denial (or from week 7, whichever is later), the family pays the full Daily Rate
- The family is welcome to re-apply for CCS at any time. Re-application and eventual approval may reduce out-of-pocket costs going forward but does not retroactively reinstate the Start Now, Pay Half discount

9. Combining With Other Offers

- This offer cannot be combined with other Amara promotional offers or discounts, including the Every Child Swims swim lesson reimbursement offer
- Standard Amara programs that are not promotional in nature – including the 3 Days CCS Guarantee and sibling discounts – continue to apply in their usual way

10. Verification and Right to Decline

Amara reserves the right to:

- Verify CCS application status with Services Australia (where the family has authorised such verification as part of their enrolment)
- Request additional information or documentation at any time
- Decline to apply the discount, or cease the discount, where Amara has reasonable grounds to believe that the eligibility requirements have not been met or that the family has provided false or misleading information
- Take legal action to recover any discount applied on the basis of false or misleading information

Amara's decision in relation to eligibility is final for the purposes of administering this offer, and is without prejudice to your rights under the Australian Consumer Law or to make a complaint to the Department of Education, the Western Australian Department of Mines, Industry Regulation and Safety, or any other applicable body.

11. Privacy

- Personal information collected for the purposes of this offer (including CCS application confirmations) will be handled in accordance with Amara's Privacy Policy, available at <https://www.amaraelc.com.au/privacy-policy/>
- CCS application confirmations are retained securely for the minimum period required for tax and audit purposes (typically 7 years)
- By enrolling under this offer, you consent to Amara using your information to process, administer, and verify the discount

12. Limitation of Liability

- To the maximum extent permitted by law, Amara is not liable for any loss, damage, or expense arising from any delay in CCS processing by Services Australia, or from any change in CCS eligibility or rates during or after the discount period

- Nothing in these Terms excludes, restricts, or modifies any guarantee, right, or remedy that cannot be excluded under the Australian Consumer Law

13. Amendments

Amara reserves the right to amend these Terms and Conditions where necessary for legal, regulatory, or operational reasons. Any material changes will be communicated to participating families in writing (by email) at least 14 days before they take effect, except where the change is required by law to apply immediately. Changes will also be published on the offer landing page and will apply to all new enrolments from the date of the change.

14. Governing Law

These Terms and Conditions are governed by the laws of Western Australia and the Commonwealth of Australia. Any disputes are subject to the exclusive jurisdiction of the courts of Western Australia.
